## "2023 LEXUS ULTIMATE DAY OF GOLF" SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE STATE OF NEW YORK, NEW JERSEY AND CONNECTICUT AND WHERE PROHIBITED OR RESTRICTED BY LAW.

**DATES OF SWEEPSTAKES:** The "2023 Lexus Ultimate Day of Golf" Sweepstakes (the "Sweepstakes") begins at 12:00 a.m. Eastern Standard Time ("EST") on May 17, 2023 and ends at 11:59 p.m. EST on June 11, 2023 (the "Sweepstakes Period").

Then, click the "Submit" button in order to receive one (1) entry into the Sweepstakes. **There is a limit of one (1) entry per Entrant during the Sweepstakes Period.** 

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant's entry and that Entrant may be disqualified from the Sweepstakes. WINNER SELECTION/NOTIFICATION: On or about June 15, 2023, one (1) Grand Prize Winner will be selected at random from among all eligible entries received during the Sweepstakes Period. Odds of being selected as the Grand Prize Winner are based upon the total number of eligible entries received during the Sweepstakes Period. The potential Grand Prize Winner will be notified by telephone between the hours of 8:30 a.m. ET and 4:30 p.m. ET from June 17, 2023 to July 19, 2023 ("Notification"). Independent Administrator will make two (2) attempts to reach the potential Grand Prize Winner via the Notification. Notifications will not be left on answering machines / voicemail.
