## MEMORANDUM TO PLAYERS

---

### **COVID-19 GUIDELINES**

In response to the ongoing COVID-19 Pandemic, the MGA has released Guidelines for MGA-Sanctioned events. That all competitors are required to follow. Please reference this document before arriving to the event. [CLICK HERE](#) for the MGA COVID-19 Guidelines.

### **FORMAT**

This event is a one-day 18-hole stroke play competition. If necessary, to determine the qualifiers and/or alternates, there will be a sudden death playoff which will begin immediately at the conclusion of play. All players should keep informed as to the time and status of any playoff.

### **GENERAL**

- All players are required to have their own face mask/ covering while they are on property and face masks must always be worn indoors and outdoors except when, sitting at a table eating/drinking, during their round, or while practicing.
- The Golf Shop and Practice Range will open at 6:30 a.m. Range balls will be available for purchase for \$5.00 (**cash only**).
- Locker Room will open at 6:30 a.m. (**Restrooms only**).

### **REGISTRATION AND START OF PLAY**

Players are requested to check in upon their arrival at the course. Contestants are to report to their assigned starting tees, ready to play, 10 minutes before their scheduled starting times. Caddie arrangements should be completed before players report.

### **SCORECARDS**

Players will be provided physical scorecards for the qualifier. Hole by Hole scores **must** be certified by the player and marker at the scorecard collection area at the conclusion of the round. Players **must** wear a mask at the scorecard collection area and **should** use hand sanitizer/disinfectant after leaving the scorecard collection area.

### **PRACTICE ROUND**

Players have been accorded the courtesy of a practice round on the following days **after 2:00 p.m.:**

- Thursday, April 15
- Thursday, April 22

Players must contact Caddie Manager, Ed Smith at (631) 425-6194 at least a week in advance to make arrangements on a first-call basis. The cost of a practice round is \$30.00 (plus tax) which includes the use of a motorized cart. Limited availability and **no** guests allowed. Standard club policies apply.

Players are **only** permitted to use the practice facilities of Huntington Crescent Club on the day of their scheduled practice round **and** arrive no earlier than one hour before their scheduled practice round.

## **DRESS**

Players must be neat in appearance with respect to clothing and personal grooming. Players and caddies must wear collared shirts. The wearing of jeans, cargo shorts, and cargo pants is prohibited. The Committee in charge decides whether this requirement has been met and has authority to withdraw the entry of a player who does not comply.

## **FOOD SERVICE**

- A continental breakfast will be provided by the MGA from 6:30 a.m. to 9:00 a.m. outside of the Golf Shop.
- Luncheon service will be available for purchase (**cash only**) from 11:00 a.m. to 3:00 p.m. on the Patio.
- Players will **not** be permitted to stop to eat between nines.

## **CADDIES**

- There is a **limited supply** of caddies at Huntington Crescent Club. Players must contact Caddie Manager, Ed Smith at (631) 425-6194, in advance to reserve a club caddie on a first-call basis. The caddie fee is \$100.00 (tip not included).
- Players may bring their own caddie.
- Players may carry their own bag.
- It is **strongly recommended** that caddies wear shoes without spikes or tread.
- Players are **not** permitted to use pull carts.

## **LOCAL RULES**

- The "One Ball Rule" will be **in effect**.
- Distance Measuring Devices will **be permitted**.

## **PACE OF PLAY**

It is a condition of the competition that "the Player shall play without undue delay and in accordance with any pace of play (POP) guidelines that the Committee may establish" and with the prescribed penalties for slow play. The MGA will be closely monitoring the POP at all MGA and USGA competitions. Chronic slow play takes away much of the enjoyment of the game of golf and we ask that you please be courteous of your pace. We appreciate your cooperation with the [MGA Pace of Play Policy](#)
